PROCLAMATION DECLARING JAMES CAMPBELL TOWN OF WEST PELZER POET LAUREATE

WHEREAS, the Town of West Pelzer wishes to cultivate an enriched arts community with an emphasis on visual, performance, and literary arts — where poetry tells the history of human feeling and can sustain the emotional memory of a community; and

WHEREAS, poetry can carry us to the frontiers of linguistic imagination so that we can articulate our vision of the future, understanding that poetic traditions allow us to know more about our own culture and can serve as a passport to the cultures of others; and

WHEREAS, a poet laureate of West Pelzer seeks to help foster a passion for the reading, writing, sharing, and celebration of poetry; and

WHEREAS, on November 10, 2020, the Mayor selected James Campbell as the inaugural honorary position of Poet Laureate of the Town of West Pelzer, South Carolina; and

WHEREAS, James has demonstrated through his published works a passion for the expression of ideas through the written word and has exemplified a desire to foster a love for writing and poetry in others through facilitating writing workshops for both middle and high school students and the community at large; and

WHEREAS, James consistently creates and contributes poetry, lyrical, and literary works to be shared through multiple platforms and venues in our community and has received multiple acknowledgements and awards for his written works; and

WHEREAS, the West Pelzer Poet Laureate will be required to:

- 1. Visit schools and attend Town, library, and school functions as needed;
- 2. Be available for service over the two-year term;
- 3. Carry activities that engage the public in poetry or literary arts;
- 4. Give a reading at special Town events;
- 5. Write a summation of his/her impressions and experiences as Poet Laureate prior to the end of the two-year term, with the purpose of providing information that will help to improve, adjust or adapt the parameters of the post.

BE IT RESOLVED, by the Mayor and City Council this 10th day of November 2020, that the Town of West Pelzer is hereby authorized to select a Poet Laureate for the Town for a term of two years; and,

NOW, THEREFORE, BE IT RESOLVED, I, Blake Sanders, Mayor of West Pelzer, do hereby appoint James Campbell as the Inaugural West Pelzer Poet Laureate.

RESOLUTION NO. 2020-1110 RESOLUTION TO APPROVE THE CAPITAL IMPROVEMENT FUNDING FOR SAFETY IMPROVEMENTS TO TOWN HALL AND OTHER MUNICIPAL FACILITIES

WHEREAS, the Town of West Pelzer identifies and considers public facilities owned by the Town are in need of upgrades to accommodate an increased need for public safety; and

WHEREAS, the Town has received quotes for public safety improvements that would deter the spread of COVID-19, increase safety of employees; and provide opportunities for staff to identify and mitigate safety concerns prior to engagement; and,

WHEREAS, the Town Council finds that this resolution is in the best interest and welfare of the residents of the Town.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WEST PELZER, SOUTH CAROLINA, AS FOLLOWS:

Section 1: The Town will fund from the Capital Improvement Budget PPE barriers in the lobby, automatic door closers, security cameras, and other improvements as deemed necessary.

Section 2: Total budget shall not exceed \$5,000 inclusive of all services required.
