Councilman Lee made a motion to approve, 2<sup>nd</sup> by Councilman Riddle; all were in favor.

### CITIZEN COMMENTS (sign up required / max 3 minutes

Joyce Vanhook – stated that her husband was upset with the new utility payment system and the convenience fee that is charged; Payton responded that this was part of the upgrade and all fees are retained by nexbillpay and not the Town. Customers can continue to pay by check or cash at the office, via mail or the drop box to avoid the fee. Joyce Vanhook – stated that she was concerned with the amount of delivery truck traffic on Park Street; stated that the trucks are taking the secondary roads to avoid traffic congestion on Main Street. Mayor Sanders asked Chief Stoller to look into it.

## **OLD BUSINESS**

Second Reading of Ordinance 2022-1213 "AN ORDINANCE TO REZONE APPROXIMATELY 5 ACRES OF REAL PROPERTY LOCATED NEAREST 501 WOODCOCK ROAD AND 190 MILL STREET, WEST PELZER, SOUTH CAROLINA 29669 (TAX MAP NUMBERS 2431301023, 2431301024, 2431301005, 2431301004, 2431301003, 2431301001, 2431302002, 2431302001) TO R-6 HIGH DENSITY RESIDENTIAL / MULTI-FAMILY" Clerk's Comments: Property was posted prior to the scheduled planning commission meeting; No formal vote was taken by the planning commission due to a lack of a quorum; General consensus of the group was to recommend council approval; Current zoning is R-20; Requested zoning is R-6 High Density Residential Multi-family; First reading was passed by Council at the December 13, 2022, meeting. Councilman Lee made a motion to approve, 2<sup>nd</sup> by Councilman Riddle; all were in favor.

### **NEW BUSINESS**

Discussion to Repeal Town Code 18.202 "Manner of Driving a Motor Vehicle, Points

Clerk's Comments: This item was added to the agenda at the request of the majority of Council; Mayor Sanders asked Judge Turner to advise; Judge Turner stated that Code 18.202 was a procedural matter. Councilman Lee stated that the Council's concern was the speed on Main Street and pedestrian safety. Mayor Sanders added that it was his understanding that this had been taken care of and Council does not need any additional input; Judge Turner agreed.

#### Resolution 2023-0110 "A RESOLUTION TO ACCEPT 2023 P.A.R.D. GRANT FUNDING"

Clerk's Comments: Anderson County Legislative Delegation has endorsed a PARD grant award in the amount of \$20,000 for a project for the expansion of Chapman Park; The delegation requires a commitment (in the form of a Resolution) prior to the official award of PARD funds.

Councilman Riddle made a motion to approve, 2<sup>nd</sup> by Councilman Lee; all were in favor.

#### Resolution 2023-0110.1 "APPOINTMENT OF MUNICIPAL ELECTION COMMITTEE MEMBER"

Clerk's Comments: All general and special elections must be conducted by a Municipal Election Commission; Commission is composed of 3 electors who are residents of the Town; Currently we only have 2 active members. The resolution is to appoint Debra Scroggs.

Councilman Lee made a motion to approve, 2nd by Councilman Riddle; all were in favor.

Payton added that there would be a special election on March 28, 2023 to fill the vacant Council seat; filing will open on January 20, 2023 at 12pm and close on January 30, 2023 at 12pm.

WHEREAS, Vicars Construction has applied to the Town Planning Commission and Town Council to rezone a piece of property located nearest 501 Woodcock Road and 190 Mill Street; and

**WHEREAS,** the parcel of property, known as Tax Map Numbers 2431301023, 2431301024, 2431301005, 2431301004, 2431301003, 2431301002, 2431301001, 2431302002, & 2431302001 and located nearest 501 Woodcock Road and 190 Mill Street is currently zoned R-20; and
