WHEREAS, with approaching warm weather, more motorcycles will be on the roadways; and

WHEREAS, many individuals throughout our community operate motorcycles for pleasure and enjoyment or it is their main source of transportation; and

WHEREAS, each year many cyclists are injured or killed as a result of motorcycle accidents on the roadways; and

WHEREAS, since motorcycles lack the protective armor of automobiles their operators are at even greater risk of serious injury or death by accident; and

WHEREAS, a great many of the accidents and injuries involving cyclists annually are the result of encounters with operators of automobiles; and

NOW THEREFORE, the Town Council of West Pelzer hereby encourages motorists to acknowledge and be aware of the increasing volume of motorcycles sharing our roadways.

ORDINANCE NO. 2023-0613 AN ORDINANCE FOR ADOPTION OF THE 2021 INTERNATIONAL PROPERTY MAINTENANCE CODE

An Ordinance of the Town of West Pelzer adopting the 2021 edition of the International Property Maintenance Code, regulating, and governing the conditions and maintenance of all property, buildings, and structures.

The Town Council of West Pelzer does ordain as follows:

SECTION 1. That a certain document is on file with the office of the Town Clerk of West Pelzer, being marked and designated as the International Property Maintenance Code, 2021 edition, as published by the International Code Council, be and is hereby adopted as the Property Maintenance Code of West Pelzer, South Carolina for regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use and the demolition of such structures as herein provided; and each and all of the regulations, provisions, penalties, conditions and terms of said Property Maintenance Code on file in the office of the Town Clerk are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any prescribed in this ordinance.

SECTION 2. Any other ordinances in conflict herewith are hereby repealed.

SECTION 3. That if any section, subsection, sentence, clause, or phrase of the ordinance is for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The West Pelzer Town Council hereby declares that it would have passed this ordinance, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

SECTION 4. That nothing in the ordinance or in the Property Maintenance Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed a citied in Section 2 of this ordinance; nor shall any just or legal right or remedy of any character by lost, impaired or affected by this ordinance.

SECTION 5. That the office of the Town Clerk is hereby directed to cause this ordinance to be published for public view.

SECTION 6. That this ordinance and the rules, regulations, provisions, requirements, orders, and matters established and adopted hereby shall take effect upon second and final reading of this ordinance.

RESOLUTION NO. 2023-0711

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF WEST PELZER, SOUTH CAROLINA REQUESTING MEMBERSHIP IN THE ANDERSON AREA TRANSPORTATION STUDY (ANATS).

WHEREAS, the Town of West Pelzer is a municipality within Anderson County, and along with the Town of Pelzer and Williamston is its own Census defined Urban Area

WHEREAS, the Anderson Area Transportation Study (ANATS) is a Metropolitan Planning Organization (MPO) designated by the South Carolina Department of Transportation (SCDOT) and Federal Highway Administration (FHWA)

WHEREAS, the Anderson Area Transportation Study (ANATS) serves as the long range planning body for all designated federal transportation and transit funds provided by the current transportation bill

WHEREAS, the Town of West Pelzer is requesting membership in the Anderson Area Transportation Study as a full voting member of the Policy Committee

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF WEST PELZER THAT:

- 1. The Town of West Pelzer's Mayor serves as the voting member on the Anderson Area Transportation Study's Policy Committee
- 2. Membership in the Anderson Area Transportation Study includes attendance to the Study Team Meetings as well as town residents ability to apply to the Citizen's Advisory Board
- 3. This resolution shall take immediately upon its adoption by the Mayor and Council and shall be forwarded to the Anderson Area Transportation Study (ANATS) for consideration.
