Payments are due before the 15<sup>th</sup> of each month and a \$15 delinquent fee will be added on the 16<sup>th</sup>. The Town of West Pelzer has the authority to discontinue said services if any bill is not paid in full before the 25<sup>th</sup> of each month. (disconnections begin at 9am on the 25<sup>th</sup> of each month) An electronic notification of disconnection will be sent to the contact on file. If service is discontinued a \$50 RECONNECTION FEE plus the outstanding balance of the account will be due in full before service will be reinstated, in accordance with the Town's said "Rules and Regulations".

\*By signing this service agreement for water/sewer, the applicant agrees to pay all costs of collection of the applicant's unpaid bills. The Town of West Pelzer has the right pursuant to the South Carolina Setoff Debt Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If the Town of West Pelzer chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through the Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through the setoff process, including fees charged by the Department of Revenue, the Municipal Association of South Carolina, and the Town of West Pelzer. If the Town of West Pelzer chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well.
